INVESTMENT APPROACH

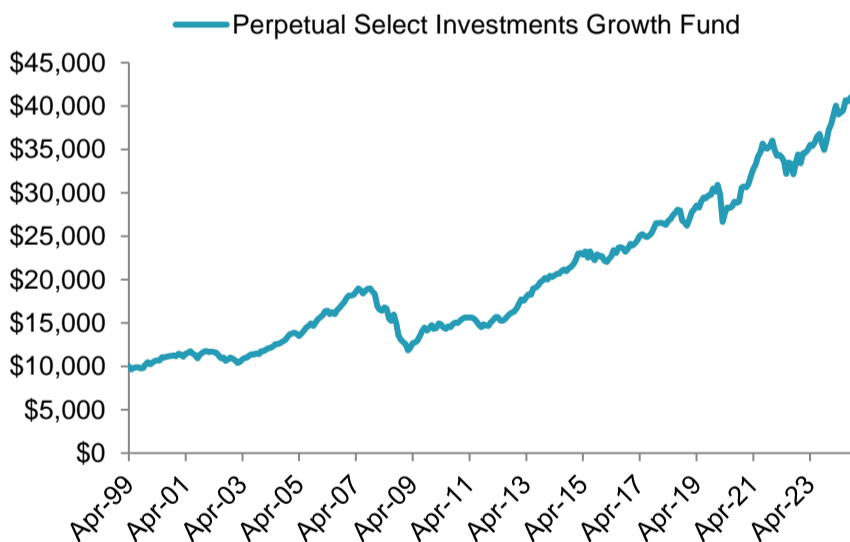

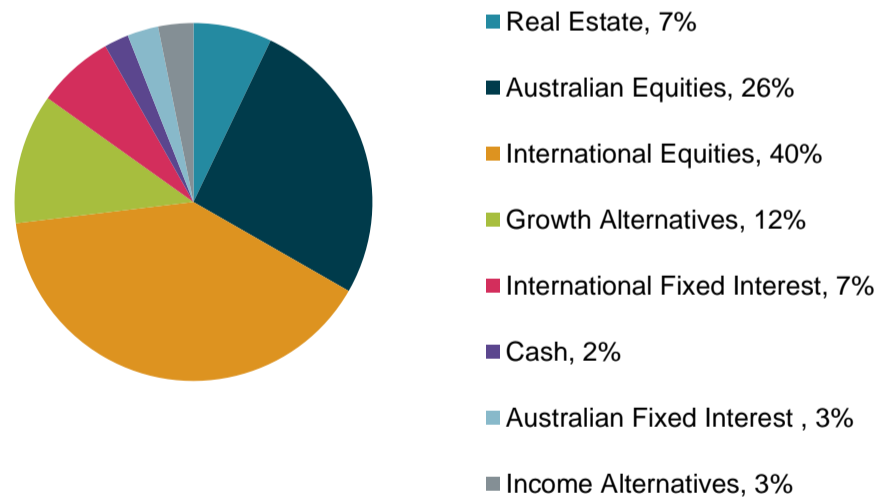
