About this document

This Target Market Determination (TMD) is required under section 994B of the Corporations Act 2001 (Cth) (the Act). Consumer selected investment options

This section provides information on the investment options offered in the Perpetual WealthFocus Pension Plan (the Plan). The specific risks of one of the options, Perpetual Geared Australian, are given below. This is because it has a very high or extremely high risk and return profile, with the potential for significant volatility and losses.

Perpetual Geared Australian

The Perpetual Geared Australian investment option is designed for consumers who:

- are seeking capital growth
- are intending to use the investment option as a satellite allocation within a portfolio
- have a minimum investment timeframe of 7 years or longer
- have a very high or extremely high risk and return profile

.

An investment option's investment strategy may involve specific risks. Specific risks associated with this investment option include:

Investment Volatility Risk: The risk there is a high level of volatility in the value of your investment because of a particular asset class or investment strategy. The value of your investment may vary significantly from day to day.

Drawdown Risk: The steep decline in value of a single investment or an investment portfolio from a relative peak. Any time taken to recover a drawdown can vary considerably due to the nature of the underlying assets, the investment strategy, market conditions and the size of the drawdown.

Gearing Risk: With gearing, the investment manager borrows money from a lender to increase the amount the investment option can invest. While this can result in larger investment gains in a rising market, it is also likely to magnify losses in a falling market. Gearing increases the volatility of an investment option's investment returns. Consequently, a geared investment option is considered to have a higher investment risk than a comparable investment option that is ungeared.

Asset Class Concentration Risk: Investing in an investment option with a smaller number of investments or exposure to solely one asset class such as Australian Shares may lead to more volatile returns than investing in an investment option with a more diversified portfolio with a larger number of positions or exposure to multiple asset classes.

Prime Broker Risk: PIML in its capacity as the responsible entity of the underlying investment fund for Perpetual Geared Australian investment option engages

a prime broker to provide financing for gearing and stock for the borrowing and lending of securities, as well as settlement services for the underlying investment fund and any other services agreed between the parties. When the underlying investment fund borrows securities or cash, the prime broker is entitled to take collateral from the assets of the underlying investment fund. Any assets taken by the prime broker may be used by the prime broker for its own

purposes (including lending those assets to third parties) for the period that the underlying investment fund retains the relevant liability. Therefore, there is a risk that if the prime broker becomes insolvent whilst the underlying investment fund remains indebted to the prime broker, the investment assets of the underlying investment fund may not be returned in full.

We consider the investment option is most suitable for consumers who have a very high or extremely high risk and return profile and:

- are seeking an investment option that has low diversification
- are seeking to maximise returns
- · can accept higher potential losses, especially in the short-term, and
- are comfortable with the aforementioned specific risks associated with the investment option

Given the very high / extremely high risk level, no more than 30% of any investment in the Plan can be allocated to Perpetual Geared Australian.

Investment options and diversification

A consumer (or class of consumer) may intend to hold an investment option as part of a diversified portfolio (for example, with an intended investment option use of minor allocation). In such circumstances, the investment option should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. In this case, an investment option with a High risk/return profile may be consistent with the consumer's objectives for that minor allocation notwithstanding that the risk/return profile of the consumer as a whole is Medium. In making this assessment, distributors should consider all features of a product (including its key attributes).

Appropriateness requirements

Explanation of consistency of key attributes with TMD

The Perpetual WealthFocus Pension Plan (the Plan) is a simple to use retirement income product, designed for advised or self-directed consumers looking to invest for an income stream in retirement (an account based pension) or transitioning to retirement (a transition to retirement pension).

Please note that minimum drawdown rates apply, meaning the Plan may not be suitable for consumers who do not intend to receive an income stream from it. Additionally, eligibility conditions must be met. For an individual to initiate an account-based pension, they must have satisfied a condition of release from superannuation. In the case of a transition to retirement pension, the consumer must have reached their preservation age. It's important to keep in mind that the Plan may not be suitable for consumers who do not meet these eligibility conditions.

The Plan offers a range of investment options (which have different levels of risk and generate investment returns in different ways, over different timeframes and from different asset classes) enabling consumers to select the investment option(s) that most closely meet their own particular needs and circumstances.

Consumers also have the flexibility to change their investment selection as their needs and circumstances change over time. With a diversified range of investment options and asset classes, it may be suitable for consumers across a range of risk profiles and investment horizons.

Consumers seeking to choose from a limited investment menu may choose to invest in multi-asset class options that are classified by risk (conservative, balanced and growth) that are suitable as a stand-alone solution.

The Plan may be suitable for retirees seeking the flexibility to choose the frequency of income payments from their pension and alter the amount as their needs change (subject to the Government's minimum withdrawal requirements). It may also be suitable for retirees who wish to access their superannuation via lump sum withdrawals and for retirees over 60 years of age who are seeking zero tax on income payments.

The choice and flexibility offered by the Plan, in both investment options and payments, make it suited for consumers seeking to select their investment options and payment rates as suited to their own particular needs and circumstances. Consumers may do this independently or with the assistance of their financial adviser.

This TMD uses the Standard Risk Measure (*SRM*) to estimate the likely number of negative annual returns for an option over a 20 year period, using the guidance and methodology outlined in the <u>Standard Risk Measure Guidance Paper For Trustees</u> (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some options may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.
